ICBR has the REALTOR® membership categories of Primary and Secondary. Primary members pay their Indiana Association of REALTORS® (IAR) and National Association of REALTORS® (NAR) dues through ICBR. Secondary members are members of another local board or association of REALTORS® through which they pay IAR and NAR dues.

All applications are approved by the Board of Directors at monthly meetings, so dues are prorated based on the month your application is presented for approval. See application deadlines below to determine which month your application will be approved and pay the corresponding prorated dues and fees.
