Criteria for REALTOR[®] of the Year:

Must be a REALTOR[®] member of the Indiana Commercial Board of REALTORS[®] (ICBR)

Industry Impact – Exhibits professional leadership and expertise to the commercial real estate industry.

Civic Activity – Local, state and national level participation in civic and service clubs, economic development organizations, charitable activities, political commissions, fraternal or religious groups, or activities that made their community a better place.

REALTOR[®] Spirit – High principles of integrity, adherence to the REALTOR[®] Code of Ethics, and furtherance of the principles of good real estate practice among brokers, agents and the general public.

ICBR Association/Board Activity – ICBR offices held and committee work, special assignments, event participation and educational work. Membership and offices held in local chapters of Institutes, Societies and Councils.

IAR or State Association Activity – State offices held and committee work, membership and work with Indiana Association of REALTORS[®] (IAR) or within Institutes, Societies and Councils, attendance at state conventions, directors meetings and educational conferences.

NAR or National Association Activity – National offices held and committee work, membership and work with National Association of REALTORS[®] (NAR) or within Institutes, Societies and Councils, attendance at national conventions, directors' meetings and educational conferences.

In addition, the winner of the State REALTOR[®] of the Year award is automatically submitted for the 2016 NAR REALTOR[®] of the Year award.
